**Subject: Public Disclosure Scheme (PDS) of Union Public Service Commission (UPSC) - reg.**

Madam/Sir,

This is regarding utilization of the list of candidates in Public Disclosure Scheme of Union Public Service Commission (UPSC). The UPSC has formulated the Public Disclosure Scheme, the main objective of which is to provide employment opportunities for non-recommended (candidates who qualify the written examinations but are not recommended after the interview) candidates of UPSC examination in government organizations, PSUs and private companies.

2. In this regard, UPSC has been publishing the details of the non-recommended (candidates who qualify the written examinations but are not recommended after the interview) willing candidates of the Commission's Examinations under the Public Disclosure Scheme on its website. To streamline the process and widen the scope of PDS, the UPSC has launched a dedicated portal wherein any private company or a PSU can register on the portal to identify suitable candidates in line with their requirements.

3. In this context, a meeting was held under the chairmanship of Secretary, UPSC on Public Disclosure Scheme (PDS) on 17<sup>th</sup> January, 2025 at UPSC, New Delhi, focusing on the dissemination of information to the organizations under the Ministry/Department regarding the newly launched portal of UPSC (<https://upsonline.nic.in/miscellaneous/pdoiac/>) regarding Public Disclosure Scheme and streamline and widen the scope of the scheme. It has been desired that the organizations may get themselves registered on the UPSC portal/directly contact examination branch of UPSC to get the access of non-recommended candidates who


have given their willingness for disclosure subsequent to which the recruitment process can be initiated by the organizations.
