



Dear Sir,

With reference to the subject cited above and listed references, it may be noted that in compliance with Clause 12 of work order, a one month notice was served upon you vide ref. 5 above for major breach of agreement (more particularly described in reference 5 above). In furtherance to same, the Competent Authority has decided to terminate the agreement for "Manning Operation and Maintenance of Pilot Launch Surendra Sai for a period of 03 years" with immediate effect under clause 12 of the work order, along with forfeiture of Performance Security Deposit of Rs. 5,63,892/- (Rupees five lakhs sixty three thousand eight hundred ninety two) only submitted by you in shape of BG bearing No. 00726BGM2023000006 dated 20.03.2023 having its validity till 19.05.2026 and debarring you from participating in any future Tender of Paradip Port Authority for a period of two years.
