### Amendment of Recruitment Rule for the year 2021

#### NOTIFICATION

No. 1975-AD/RR/I/07/2020

dated the 18th August 2021

In compliance of the order of the Ministry of Shipping, vide No. PR-11011/1/2012-PE-I dated 8<sup>th</sup> July, 2013, the Recruitment Rules of all Class II, III & IV posts of PPT was Notified in the extraordinary Gazette of Odisha No. 298 on 11.02.2019.

2) Now, in accordance with the Provision of Section 132 of Major Port Trust Act, 1963, for Class II, III & IV Posts of Paradip Port Trust, the Board of Trustees of PPT, in the meeting dated 31.03.2021, has approved of amendment to the Recruitment Rules in respect of Pump Operator Gr. I, Pump Operator Gr. II & Carpenter Gr. II, and the same have been set out in the Annexure.

3) This may be called the 2<sup>nd</sup> amendment to the Recruitment Rule of Class II, III & IV Posts of Paradip Port Trust, 2021.

3) The said amendment shall come into force from the date of Publication of the Notification in the Official Gazette.
